

National Center for Health Statistics Research Data Center National Hospital Care Survey 2019, 2020, and 2021 Restricted Use File Data Dictionary

This document contains the data dictionary for the 2019, 2020, 2021 National Hospital Care Survey (NHCS) data in the National Center for Health Statistics and Federal Research Data Centers (RDC). NHCS collects data on patient care in hospital-based settings to describe patterns of health care delivery and utilization in the United States. NHCS receives data from billing and electronic health record sources, to learn more <https://www.cdc.gov/rdc/data/b1/NHCS-RDC.pdf>. Hospital setting data collected in the survey include inpatient and emergency departments (ED).

In calendar year 2019, 112 hospitals submitted 2,228,190 inpatient encounters and 106 hospitals submitted 5,549,330 ED encounters from January 1, 2019 to December 31, 2019. Due to the low response rate, the 2019 NHCS data are not nationally representative.

The response rate for the 2020 and 2021 NHCS is high enough for the data to be nationally representative. Weighted estimates for the 2020 and 2021 NHCS data are currently being developed and will be available in the RDC once they are complete. In calendar year 2020, 150 hospitals submitted 2,832,062 inpatient encounters and 199 hospitals submitted 7,978,530 ED encounters from January 1, 2020 to December 31, 2020. In calendar year 2021, 197 hospitals submitted 3,672,491 inpatient encounters and 236 hospitals submitted 9,980,942 ED encounters from January 1, 2021 to December 31, 2021.
