

# CDC Disease Intervention Specialists Workforce Development Funding

The Disease Intervention Specialists (DIS) Workforce Development Funding is part of the American Rescue Plan Act of 2021. This \$1 billion investment will be used over a five-year period. For the first year, the DIS Workforce Funding will be distributed as a Year 3 Supplement to [PS19-1901: STD Prevention and Control for Health Departments \(STD PCHD\)](#).
