Clinical Case Series Format

Thank you for participating in the Clinical Case Series during the 2014 STD Prevention Conference. This is the first time we have included Clinical Cases at this conference, and we know this will be an excellent addition to the conference program - we appreciate your willingness to participate.

Below are some general guidelines for the clinical case sessions. Sessions start very early in the morning (7am), and each session is just 50 minutes in duration, with 2 cases per session. That means that everyone should make a special effort to arrive ON TIME for the session, and moderators will have to be very strict about imposing time limits on presenters and discussants, to allow for audience questions and interaction. (As of this writing, the sessions are scheduled to be held in DOGWOOD B room at the Omni Hotel, North Tower.)

Moderators and Discussants will be seated on the dais at the front of the room. Presenters will be invited to stand at the podium to present the case in no more than 10 minutes – presenters may use slides to help illustrate key aspects of the case, but should be respectful of the time limitations. Discussants: please familiarize yourselves with the specifics of the cases by reading the abstracts (included at the end of this memo) well before the session date.

The general schedule of events will be as follows – the specific time intervals can be adjusted slightly, but each case presentation can last no longer than 25 minutes from start to finish:
