From San Diego International Airport:

- Merge onto N Harbor Dr from Airport Terminal Road
- Take left onto W Laurel St
- Turn left onto Sixth Ave
- Take the ramp onto CA-163 N
- Merge onto I-15 N
- Take exit 27 for Via Rancho Pkwy toward Felicita Park
- Use right 2 lanes to turn onto Via Rancho Pkwy
- Continue onto Bear Valley Pkwy
- Use right 2 lanes to turn onto E Valley Pkwy and continue onto Valley Center Rd
- Turn left onto S Resort Dr
