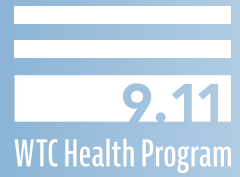


# Program Summary



As a result of their exposure to airborne toxins and other hazardous conditions arising from the events of September 11th, 2001, responders and survivors now face serious physical and mental health issues. The World Trade Center (WTC) Health Program provides medical monitoring and treatment for certified WTC-related health conditions to eligible 9/11 responders and survivors.

## Who is eligible?

- Responders to the WTC and related sites in New York City, at the Pentagon in Arlington, VA, and the site near Shanksville, PA.
- Survivors in the New York City Disaster Area who were present in the dust or dust cloud on 9/11; or who lived, worked, went to school, or attended child or adult daycare in that area in the months after.

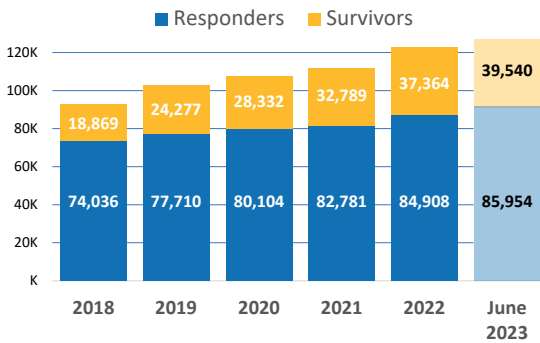

- The Program covers the conditions on the List of WTC-Related Health Conditions when the Program certifies that the condition is related to a member's 9/11 exposure.

## end of year MEMBER COUNTS



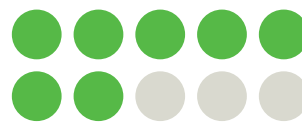
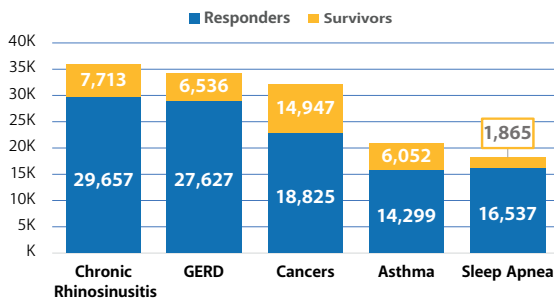

about the WTC Health Program



Established as a federal limited health program by the James Zadroga 9/11 Health and Compensation Act of 2010



Administered by the National Institute for Occupational Safety and Health in the Centers for Disease Control and Prevention



Serves eligible WTC Responders and Survivors; and Pentagon and Shanksville, PA, Responders



Provides no-cost treatment of certified WTC-related conditions only and does not replace primary health insurance



Authorized and funded until 2090



Separate from the September 11th Victim Compensation Fund ([www.vcf.gov](http://www.vcf.gov))

WTC Health Program research identifies and answers critical questions about physical and mental health conditions related to 9/11 exposure and effective treatments of those conditions.

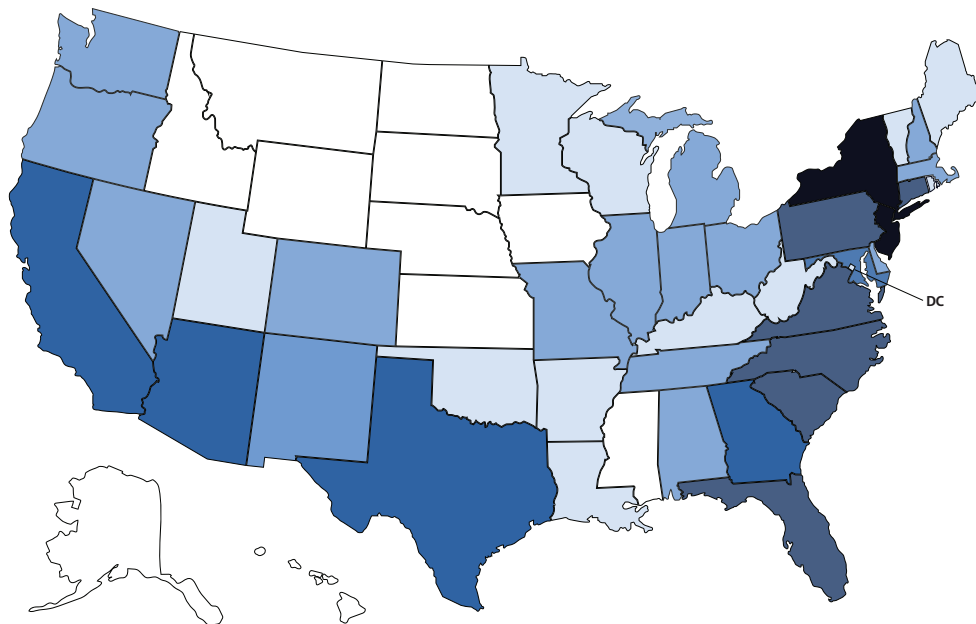
