How to Generate a Line Listing of COVID-19 Module Data Guidance for the Dialysis COVID-19 Module

Description

A line list is an organized, detailed list of each record entered into NHSN. This quick reference guide describes the process for generating a line listing report of the COVID-19 Module data.

Housekeeping Notes

Prior to generating an analysis reports, such as a line list report, users must generate a recent analysis dataset (ADS). Generating analysis datasets incorporates all data entered into the database into the analysis datasets that are used to generate analysis reports. Line List Report Example

Suppose you are interested in looking at your COVID-19 Module data for the past five weeks in one table. You would like to include a specific set of data points, such as the number of COVID-19 cases and deaths in patients and in staff, among other data points.

To run this report, access it by following Analysis > Reports > Outpatient Dialysis Pathway Data > Line Listing-Reported COVID-19 Dialysis Outpatient and Staff Pathway Data.

Modifying the Report

Below is a guide on how to modify analysis reports in NHSN, which also applies for this example.

<u>https://www.cdc.gov/nhsn/pdfs/ps-analysis-resources/howtomodifyreport.pdf</u>. On the modify screen, you have the options to make any limitation to the report you want. The more limitations you apply, the fewer the data points on your output report. In our example, the only modification applied is the **Time Period** using the variable **Reporting Period Begin and End Date**.

Interpreting the Report Output

After you select run, as shown the screenshot above, the Line Listing-Reported COVID-19 Dialysis Outpatient and Staff Pathway Data will be generated and appear in a separate HTML window. The example of the line listing report output is shown in the screen shot below.

You will notice the headers on the table are identical to the questions from the COVID-19 Module form. The data entered for each of the questions on the form will appear in the rows show in the screenshot below. *NOTE: You cannot run analysis reports while datasets are generating.*
