

Purpose of Document

The purpose of this guidance document is to assist facilities with re-assigning the NHSN Facility Administrator in the CDC's National Healthcare Safety Network's (NHSN's) Dialysis COVID Module. This will help prevent loss of NHSN access in the event of staff turnover.

NHSN Facility Administrator Will Be Leaving Soon

If your facility still has an NHSN Facility Administrator that is soon leaving the facility, please ensure that this role is reassigned to another user within the facility. As an alternative, at least one user should be assigned "**ALL Rights**", so that weekly reporting is not jeopardized.

Reassigning the NHSN Facility Administrator Role

• Find "Facility Administrator" on the list and click the "reassign" button on the far right of the screen. You will be asked to find and select an existing user who will be reassigned this role.



 NOTE: The existing user must be assigned as a user with administrative rights. Once selected, remember to save the updated information on the Edit Facility Information page.







Deactivating Users

• Select USERS on the left navigation bar, select FIND, and FIND again on the bottom of the screen. Select the user's profile and go to EDIT. At the USER ACTIVE drop down, toggle to YES/NO>SAVE.
