## Introduction

### Purpose

The NHSN Dialysis Event External Validation Toolkit provides recommended approaches to investigate and enhance the accuracy and completeness of NHSN Dialysis Event data.

Organizations beginning validation activities are encouraged to use the methods and tools in this document, which are intended to promote a robust national standard for evaluation of dialysis event data. Those with existing validation programs are encouraged to review the toolkit and documents and consider incorporating any elements that may enhance their current approach.

### Intended Audience

This document is designed for use by nurses, infection preventionists, or quality professionals at outpatient dialysis facilities that report to NHSN; state health department or end-stage renal disease (ESRD) network personnel who work with facilities to assure high-quality, actionable surveillance data to enhance patient safety; and other groups seeking to enhance NHSN data quality for surveillance, reimbursement, quality improvement, research, or public reporting purposes.

### Overview of Validation Activities

External validation of NHSN Dialysis Event Surveillance data is conducted by an agency outside the reporting facility, such as an ESRD Network or a state or local health department. This Toolkit recommends an evaluation process that is conducted by trained staff and uses the [NHSN Dialysis Event Surveillance Protocol](#) as the standard to make data evaluation determinations, with CDC input when necessary.

The data validation activities include a survey of the facility staff's surveillance knowledge and practices, and a review of medical records to assess concordance of facility reported data with validators' determinations of reportable NHSN data. These activities may be performed together or individually, depending on the scope and goals of your data quality validation project. All tools required to implement the evaluation project, as outlined in this document, are included in template form so they can be easily customized to your organization and specific project parameters.

Completeness and accuracy of dialysis events (numerator data) are assessed through either an on-site or remote review of patient and facility medical records and documents, and involves several key steps:

- Selection of facilities
- Selection of patient medical records within selected facilities
- Review and abstraction of data from patient and facility medical records
- Comparison of information reported to NHSN by the facility with information deemed reportable to NHSN during the medical record review

Upon completion of each facility's validation activities, the validating entity/jurisdiction develops a summary report for the facility, which addresses recommendations for data correction, surveillance program improvements, and/or additional surveillance program support when appropriate.

## Goals of NHSN Dialysis Event Validation

The goals are to:

### *Evaluate facility NHSN Dialysis Event surveillance practices:*

- Assess staff understanding of the Dialysis Event Protocol
- Assess data collection and reporting methods
- Identify common barriers to complete and accurate data collection and reporting

### *Educate dialysis facility staff on NHSN Dialysis Event Surveillance:*

- Improve staff understanding of the methods and definitions in the Dialysis Event Protocol
- Improve staff data collection and reporting practices
- Increase staff awareness of reporting resources

### *Assess and improve the quality of Dialysis Event data reported to NHSN:*

- Identify under- and over-reported Dialysis Events and provide instructions for correcting those events in NHSN
- Identify systematic and recurrent errors that may require correction to data beyond the specific feedback provided
- Suggest strategies to improve facility data collection and reporting practices

### *Provide feedback to CDC to support continuous improvement of public resources in order to:*

- Improve this Toolkit and the corresponding documents
- Develop optimal and standardized data evaluation methods
- Improve existing NHSN Dialysis Event surveillance and reporting resources, such as training materials, reporting instructions, and frequently asked questions (FAQs) to address common areas of confusion

## Feedback to CDC

Widespread reporting of NHSN Dialysis Event data and validation of these data are both relatively new. This Toolkit is intended to serve as a starting point for ESRD Networks, state health departments, and other organizations planning to conduct data evaluation and data quality improvement projects with NHSN Dialysis Event data. This Toolkit provides a standardized method that can be widely used, and field-tested data collection instruments to implement the project. Feedback from persons conducting validation activities, both during and after the process, is essential to CDC's further development and optimization of this toolkit, the standardized methods, and data collection instruments. This form collects information about the facility's surveillance methodology and understanding of the Dialysis Event Protocol and provides the interviewer with the information and opportunity to address questions and correct misunderstandings about NHSN Dialysis Event Surveillance requirements.
6	<b>Facility Validation Summary and Line Listings of NHSN Dialysis Event Reporting</b> : A summary report with line lists to provide to the facility during the debrief. Contains results of the validation efforts (including the number of charts reviewed per event type, the number of events correctly or incorrectly reported, etc.) as well as line lists of all events identified from the patients' charts with pertinent information for the facility to review.
7	<b>External Validation of Dialysis Event Summary Report</b> : A summary report to provide to CDC once validation activities are completed for your jurisdiction. Contains information related to number of facilities participating and total number of charts reviewed, refusal numbers and reasons, and methodology used.
8	<b>Medical Record Abstraction Template</b> : A standardized tool that structures the collection of Dialysis Event data from a patient's chart so it may be compared to NHSN Dialysis Event surveillance data that were reported.

## Project Timeline

The duration of each step will depend upon the scope of your organization’s validation project and the number of participating facilities. Refer to the table below for the suggested duration of these steps; several activities may occur concurrently. Consider your project’s scope and available resources and use the right-hand column to create a timeline more specific to your project.

## Pre-Validation Activities

### Ensure Project Staff Expertise

To effectively evaluate NHSN Dialysis Event Surveillance data, project staff should be very familiar with and understand the [NHSN Dialysis Event Surveillance Protocol](#) especially the event definitions and application of the 21-day rule, the Dialysis Event form, and the method for correctly completing the Denominators for Outpatient Dialysis form.

Data validation staff should complete the required NHSN Dialysis Event Protocol training, which includes reading the [NHSN Dialysis Event Surveillance Protocol](#) and completing the self-paced, computer-based NHSN Annual Dialysis Surveillance [Training](#). Staff conducting data validation activities are also strongly encouraged to read the [Frequently Asked Questions About Dialysis Event Reporting](#). Organizations may consider taking additional training on application of the protocol to challenging situations. Contact the NHSN Helpdesk at [nhsn@cdc.gov](mailto:nhsn@cdc.gov) to request additional case studies for review and other content designed to assist data evaluators, using subject line “External Validation Dialysis Event”.

### Data Review Time Period

Determine the data validation time period, which includes the months that NHSN Dialysis Event Surveillance data will be reviewed for this project. Note that some facilities do not report their data into NHSN until the CMS deadline, which is three months after the end of the quarter (e.g., October through December 2022 data are due by March 31, 2023). Therefore, it is necessary to ensure that the time period selected includes complete, up to date data with a sufficient number of dialysis events to be reviewed. It is also critical that the time period chosen be identical across all participating facilities. A period of no less than 6 consecutive months during the same calendar year is recommended. Note that because of the 21-day rule, access to patient information for the month preceding the review time period will be needed. For example, if the review period is July through December 2022, it will be necessary to review charts and records from June 2022. Sufficient time should be given at the end of the review period to ensure that facility data reported to NHSN is corrected and complete ahead of any reporting deadlines.

### Selection of Facilities

Selection of dialysis facilities for participation can be done in various ways to meet different goals. It is typically not possible or necessary to visit every facility and review every patient record. This Toolkit primarily recommends the selection of 1) a random, representative sample of facilities or when a random sample is not feasible, 2) a convenience sample of facilities (e.g., a sample of volunteer facilities). To make the most of available resources and project goals, organizations are encouraged to determine how many facilities can participate in the project and decide which of these two methods for facility selection is most appropriate for their specific jurisdiction.

Since all facilities should be accountable for accurate reporting of Dialysis Event data to NHSN, using a

random sample to select facilities for participation is preferred and will provide representative data for the jurisdiction. See [Appendix 1a](#) for instructions on how to generate and select a random sample of facilities.

Once a facility has been selected and before requesting participation, follow the steps in [Appendix 1b](#) to generate the Dialysis Event Line List report and maintain a secure copy to “freeze” the facility’s reported data for the validation timeframe. This list will also be used in the patient record selection process.

## **Solicit Facility Participation and Schedule Site Visits**

Customize Letter Template – Introduction and Request to Participate ([Appendix 2](#)) to be specific to your organization and project parameters and send to Facility Managers of the facilities selected during sampling. A follow-up phone call to answer questions and address concerns is encouraged. As Facility Managers agree to participate in the data validation project, customize the letter templates in Appendix 3 to confirm on-site visits and preparation of patient lists ([Appendix 3a](#)) and/or to confirm the details of the remote participation and preparation of patient lists ([Appendix 3b](#)). Document facilities that decline participation and reasons why to include in the summary report for CDC ([Appendix 7](#))

## **Selection of Patient Charts for Review**

### **Establish a Mechanism for Secure Data Transfer between Facilities and Your Organization**

To determine which patient charts will be reviewed, your organization will need to request specific patient lists from each participating facility, which will include protected health information (e.g., medical record numbers, patient names, etc.). Therefore, it is necessary for your organization to establish a mechanism for secure data transfer and determine how those data will be secured upon receipt.

### **Patient Chart Lists and Chart Selection**

A sample size of 40 medical records per facility is recommended. The methodology provided for the selection of medical records in [Appendix 1c](#) produces a sampling frame designed to target records that may have events. This targeted sample includes randomly selecting 20 unique patient charts from the NHSN Dialysis Event Line List report (refer to [Appendix 1b](#) for steps on generating this report) and 20 unique patient charts from five facility-provided patient lists. Each participating facility will need to provide these lists of patients. [Appendix 3a](#) (for on-site review) and [Appendix 3b](#) (for remote review) contain letter templates which can be customized as needed to request the five patient lists defined below.

1. All patients who had one or more in-center hemodialysis treatment(s) during the validation timeframe
2. All patients who received any intravenous antimicrobials in an outpatient setting during the validation timeframe
3. All patients who had any positive blood cultures between during the validation timeframe, including those during hospitalizations.
4. All patients who had any pus, redness or swelling at the vascular access site during the validation timeframe.
5. All patients who were hospitalized for any reason during the validation timeframe

## Confirmation of Site Visit

As applicable, a few days prior to an on-site visit, contact the Facility Manager to remind them of the upcoming site visit. Verify that the staff involved in NHSN data collection and reporting will be available to be interviewed, that requested patient charts will be available, and that any necessary arrangements for workspace and/or computer system access have been made.

## Checklist for NHSN Dialysis Event Data Validation Site Visits

- Facility Manager's name and contact information
- Facility address and directions, if needed
- End Stage Renal Disease (ESRD) Network/state ID badge or other identification
- List of patient charts that will be reviewed
- Access to the NHSN Dialysis Event Protocol, either electronic or printed copies for each validator
- Survey to Assess NHSN Dialysis Event Surveillance ([Appendix 5](#)) for the interviewer and note-taker copies, if applicable/needed
- Internet access if planning on entering abstracted patient chart data directly into REDCap Medical Record Abstraction Tool (MRAT) or multiple copies of word-version MRAT ([Appendix 8](#); at least one printed copy per patient chart to be reviewed)
- Other helpful supplies:
  - Calendar for each chart reviewer
  - Straight edge (e.g., a ruler) for reading data printouts
  - Stapler/binder clips
  - Pens/highlighters
  - Sticky notes/tape flags

## Conducting Validation Activities

### Chart Reviews and Site Visits

Upon arrival at the facility, following introductions, validators should reiterate the project goals, stressing the educational nature of the validation activities. Reporting staff may be worried that an unfavorable evaluation may lead to sanctions by their supervisors which may bias answers to survey questions. Every effort should be made to make participating staff feel comfortable providing honest feedback.

Validators can choose to begin by administering the Survey to Assess NHSN Dialysis Event Surveillance ([Appendix 5](#)) or by initiating the patient chart review process. If multiple evaluators are present, these activities can occur concurrently.

### Administration of the Dialysis Event Surveillance Practices Survey

Identify staff involved in NHSN data collection/reporting and administer the Survey to Assess NHSN Dialysis Event Surveillance ([Appendix 5](#)). If conducting an on-site visit, schedule time to administer the survey prior to departure. If doing chart reviews virtually, schedule a convenient time to meet with the facility staff virtually. The survey is dual purposed to assess understanding of the NHSN Dialysis Event Protocol and the facility's data collection and reporting methods, as well as provide education to improve data quality going forward.

**This educational feedback is an essential component of the validation project** and is the most valuable element to the participating facility.

During survey administration, record staff answers to all questions. The recorded answers will be used for educational discussions with facility staff during the Facility Debrief at the end of the visit. These discussions will review incorrect survey answers and reporting errors discovered during chart reviews and serve as learning opportunities for facility staff and validators. The discussions will also provide insight into areas where additional training may be beneficial.

### Patient Chart Review Process

The patient charts to be reviewed should be specified prior to any on-site visits to ensure all records are available for review on the date of the site visit. Coordinate with the facility to gain access to the requested patient charts, electronic medical records, and any other data sources needed (e.g. outside laboratory reports, hospitalization records, etc.).

Patient charts should be reviewed to identify Dialysis Events using the REDCap Medical Record Abstraction Tool (MRAT) instrument (for printable version, see [Appendix 8](#)) to collect the essential data. Look carefully for systematic reporting errors or misconceptions that could impact reporting beyond the medical records that are reviewed. An example of a systematic error would be the consistent measurement of 21 days between resolution of first set of symptoms to onset of next set of symptoms rather than measuring between onsets of first and next set of symptoms. If systematic errors are made, the facility should be asked to review and correct all numerators or denominators, not just those reviewed by auditors. These errors should be re-assessed during the next audit to assess improvement. Document all reporting errors that were identified.

### Concordance Check

A concordance check is built into the MRAT. At the end of each chart review, the reviewer will compare the validated chart data entered into the MRAT to the facility's frozen data (i.e. the DE Line List report generated from NHSN prior to contacting the facility for participation). If any findings are discordant, determine the reason for discordance. Use the NHSN [Dialysis Event Protocol](#) as the gold standard for making determinations of what is reportable. For difficult cases, seek additional input from CDC by [nhsn@cdc.gov](mailto:nhsn@cdc.gov), using subject line "Dialysis Event Adjudication".

Once all selected patient charts have been reviewed, briefly summarize the findings, with a focus on any common or repetitive errors. See [Appendix 6](#) for a report template summarizing the dialysis event data entered into the REDCap MRAT, or the corresponding SAS code located on the [NHSN External Validation webpage](#) under 'Statistical Tools'.

### Facility Debrief

Debrief the Facility Manager and any staff involved in NHSN reporting of the findings from the chart review and survey administration, using the report template in [Appendix 6](#) or the corresponding SAS code, located on the [NHSN External Validation webpage](#) under 'Statistical Tools'. This provides an opportunity to discuss your findings

in general terms, address any outstanding questions, commend staff for excellent processes and/or progress, and suggest improvements. It may also be necessary to develop a process improvement plan if serious deficiencies are found. Leave a copy of expected changes to NHSN data with the Facility Manager and mutually agree upon a deadline for changes to be made. Thank the Facility Manager and staff for their participation.

## Post-Validation Activities

### Facility Follow-up

Compile your evaluation findings using Letter Template – Post-Validation Activities Summary ([Appendix 4](#)), and send the findings to the Facility Manager, thanking them and documenting results, necessary corrections, and recommendations. When appropriate, identify systematic strengths as well as problems with surveillance, data collection, and reporting, and potential underlying reasons. Identify resource and support issues that should be addressed.

If you have instructed the facility to modify data in NHSN or re-review information due to systematic errors, follow-up with the facility in 4-6 weeks to ensure corrections were made by the agreed upon deadline.

### Aggregate, Summarize and Disseminate Findings

Following the completion of all facility site visits, medical chart reviews, and entering of data into the REDCap MRAT instrument, deidentified data should be exported out of REDCap and sent to CDC. See the [How To Guide](#) for step-by-step instructions for exporting and sending deidentified data. Contact NHSN Helpdesk at [nhsn@cdc.gov](mailto:nhsn@cdc.gov) using subject line “External Validation Dialysis Event” if you would like to discuss how to aggregate and summarize your data or write up your findings. Identify opportunities to share your findings with key stakeholders; this should include CDC and all participating facilities.

Data collected through the course of the validation project will be used to inform future CDC data quality improvement efforts, including the development of:

- Trainings to address common reporting errors
- Frequently Asked Questions
- Updates to this document

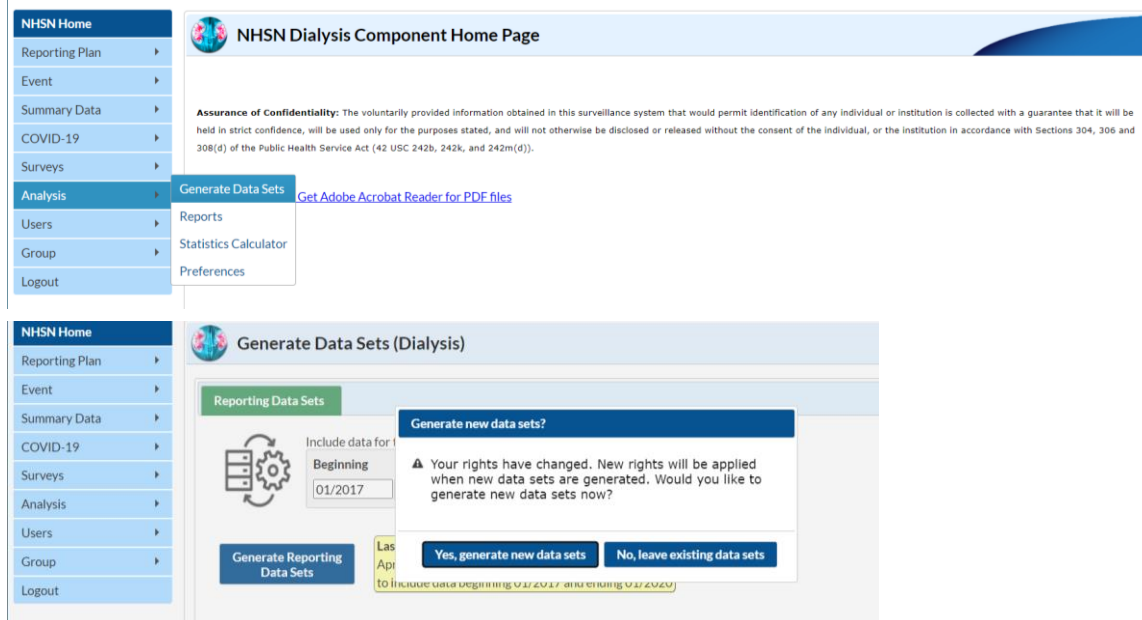

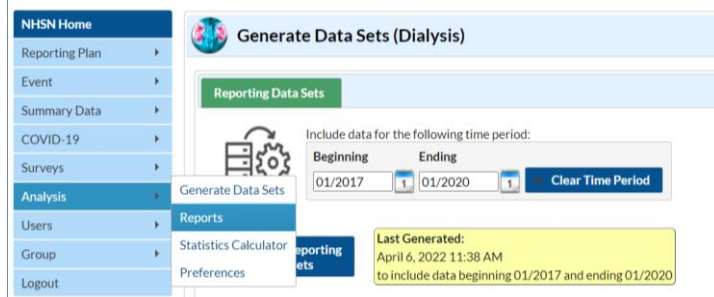
## Appendix 1: Selection of facilities, Freezing facility data, and selection of patient records for validation

### 1a: Facility Selection

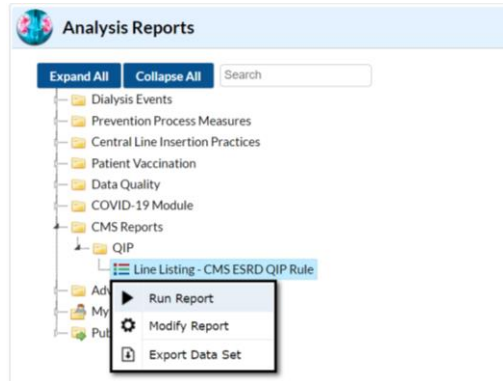
- 1) Generate new datasets in NHSN to ensure any data updates are included for analysis. On the NHSN Landing Page, navigate to the Dialysis component, and the appropriate state/jurisdiction Users' Group.
- 2) Select the "Analysis" tab and click "Generate Data Sets." Click the Generate New button. Allow the dataset generation process to complete; you can leave NHSN during the generation process. Make sure the date range listed includes the time period you are validating. If it does not, update the dates listed accordingly.



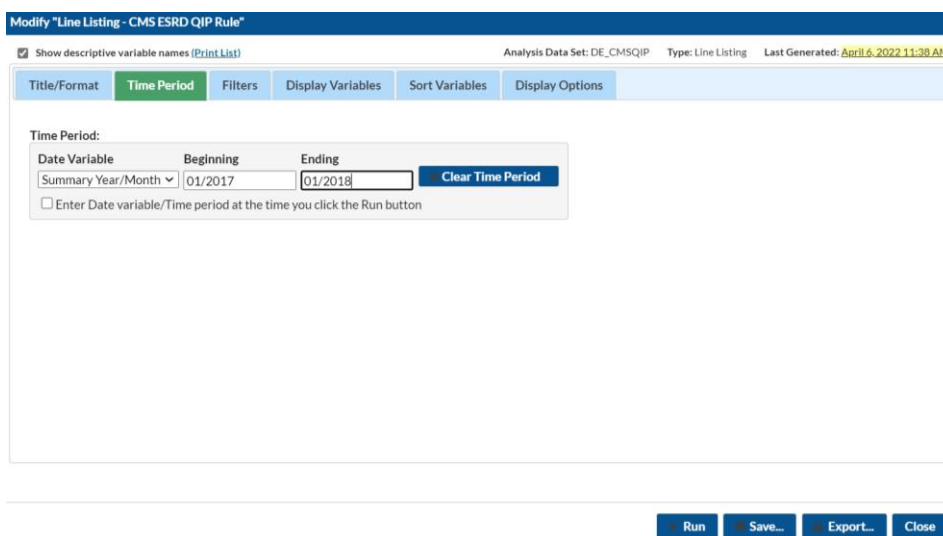
- 3) After successful dataset generation, navigate to Analysis -> Reports to display the tree view list of all analysis reports available within NHSN's analysis tool.



- 4) From Reports, select CMS Reports > CMS Reports > Line Listing – CMS ESRD QIP Rule. Click the Modify button to proceed to the modification screen, which can be used to filter and export data.



5) Use the “Time Period” tab to limit the time period of data that is included in the report to be exported as needed.



6) Click on the Export button at the bottom of the screen (not the Run button). This will prompt the “Export Analysis Data Set” dialog box to appear. Use the dropdown menu to select the file format to export the data. A .csv file type is recommended if a random number generator SAS code will be used (see [Appendix 1d](#)). **Note:** You must use the export button to generate these results. Selecting an excel file from the ‘Title/Format’ tab will not generate the needed dataset.

7) Assign each facility a random number using one of the methods outlined in the table in [Appendix 1d](#).

8) Sort facilities in ascending order by the random number assigned and select the first 30 as your sample.

9) Once you download, or “freeze”, the facilities’ data, contact the selected facilities to request participation. If

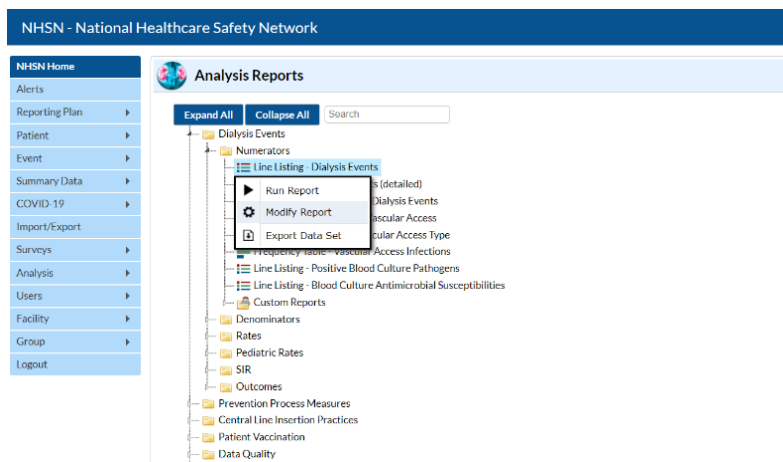


any facility declines to participate, select additional facilities from the list sorted by random number.

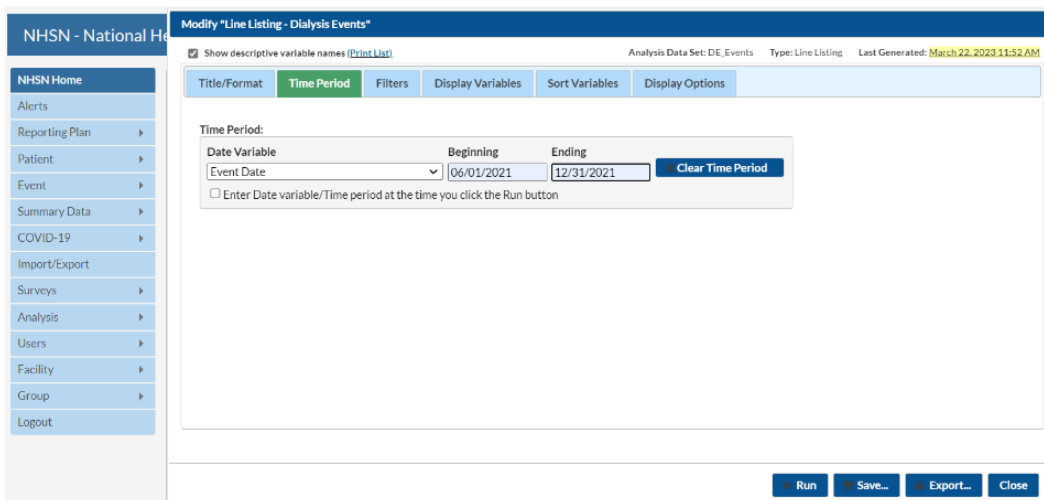
**Note:** Maintain a record of the facilities that declined to participate and the reason(s) why. When asking the facility why they are declining, tell them the information is being collected for CDC to better understand the refusal rate and reasons for not participating. In the final report submitted to CDC, you will provide the number of declining facilities and a tally of their reasons for refusal ([Appendix 4](#)).

### 1b. Freeze Facility Data/Creating the Dialysis Events Line List

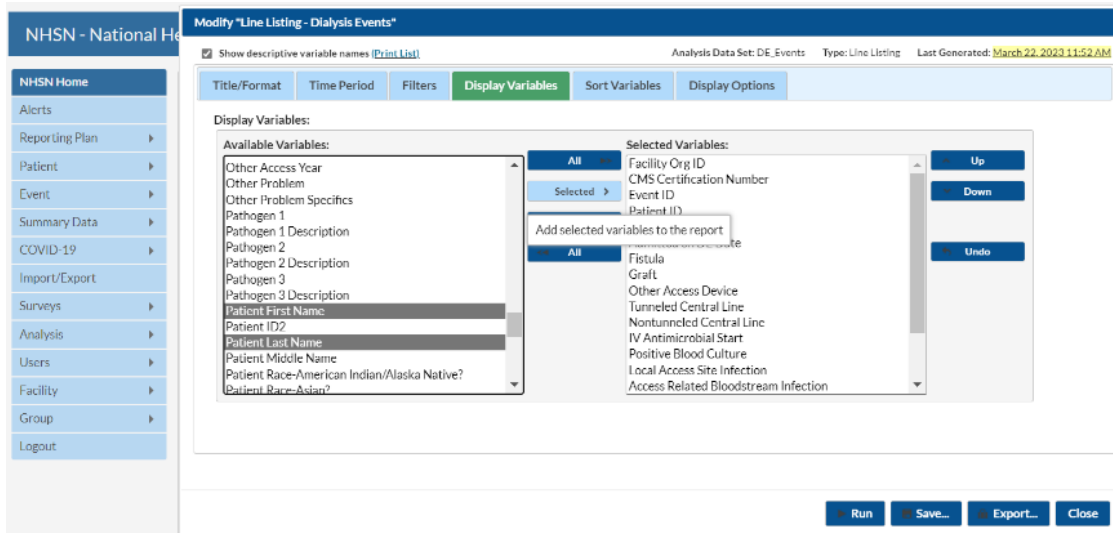
- 1) Follow steps 1 and 2 in [Appendix 1a](#) to generate new datasets
- 2) Once datasets have been generated, navigate to Analysis > Reports > Dialysis Events > Numerators > LineListing-Dialysis Events > Modify Report



- 3) Once the Modification window appears, ensure the time frame being validated is included in the dates listed. You may need to add an additional month of time for the “Beginning” range to account for the 21-day rule.

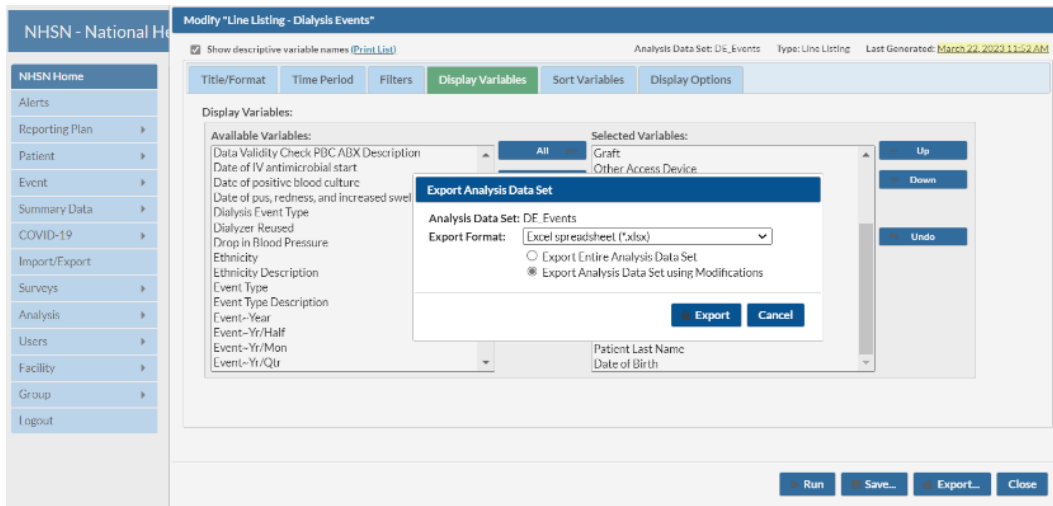


- 4) Click on the “Display Variables” tab and ensure that patient first and last name are included, as well as any other variables that may be helpful.



- 5) Click on the Export button at the bottom of the screen (not the Run button). This will prompt the “Export Analysis Data Set” dialog box to appear. Use the dropdown menu to select the file format to export the data and select the bullet for “Export Analysis Data Set using Modifications”.

**Note:** You must use the export button to generate these results. Selecting an excel file from the ‘Title/Format’ tab will not generate the needed dataset.



- 6) Store the output dataset in a secure location to reference later as needed.

### 1c. Patient Medical Record Selection Methodology

Before requesting patient charts, generate the facility's Dialysis Event Line List report from NHSN for the validation time period (this is also considered "freezing" the facilities' data reported to NHSN during the validation period). Be sure to maintain these data in a secure location. Refer to [Appendix 1b](#) for steps on generating this report. Once the data have been frozen, request facilities to send the 5 patient lists for the validation timeframe, as described in the [Patient Chart Selection](#) criteria.

- 1) Starting with the Dialysis Event Line List report, assign a random number to each event using one of the 3 methods outlined in the table in [Appendix 1d](#).
- 2) Sort by the random number and select the first 20 events. If any patients are duplicated, remove the duplicate and select the next random number.
- 3) Obtain the 5 patient lists from the facility. Refer to the [Patient Chart Selection](#) for the specific patient criteria for each list. Combine the patient lists 2-5 into a single patient list, removing any duplicate patients as needed.
  - a) If this combined, deduplicated list has 20 patients, review all.
  - b) If this combined, deduplicated list has over 20 patients, assign each patient a random number using a method from [Appendix 1d](#). Sort by random number and select the first 20 unique patients.
  - c) If this combined, deduplicated list has less than 20 patients, use patient list 1 to supplement the difference to reach 20 patients:
    - Remove any duplicate patients from list 1 that are already included in the combined, deduplicated list created from lists 2-5.
    - Assign all remaining patients on list 1 a random number, using a method from the [Appendix 1d](#). Sort by random number and select the first number of patients needed to reach 20 (i.e.- if you have 15 deduplicated patients from lists 2-5, select the first 5 patients from list 1 after sorting by random number to reach a total of 20 patients).
- 4) If the NHSN Dialysis Event Line List does not have 20 unique events, or if the facility-provided lists do not have a total of 20 unique patients, supplement the difference using the other group to reach a total of 40 records, if possible.

**Note:** If there is duplication between the NHSN Dialysis Event Line List and the facility-provided patient lists, the duplicate record(s) should be excluded from the sample and another record selected if possible. If there is not a total of 40 unique records between the two groups of charts, all unique records should be reviewed.

## 1d. Random Number Assignment Methods

Option 1: Excel	<ol style="list-style-type: none"> <li>1. Using a facility or patient list created above, insert the command =ROUND(RAND()*1000000,0) into column B (or any empty column) and drag to paste this command for each row of the facility list. This will generate a random number for each orgID (or event).</li> <li>2. Select and copy the values from column B and use the Paste Special (Paste Values) feature to paste the number values into column C. Note: any edit made to the Excel sheet will cause the numbers in column B to recalculate. This is normal and can be ignored if you have an iteration copied.</li> <li>3. 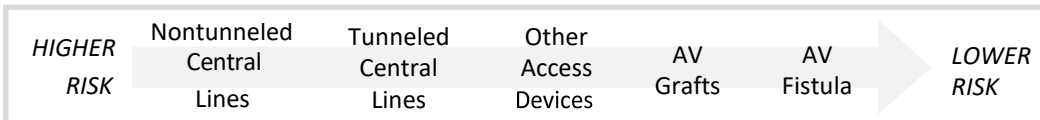

If a patient has two dialysis events of the same type, the second occurrence is reported only if there are 21 or more days between the events. If the second event falls exactly on the 21<sup>st</sup> day, it is reported.

IV antimicrobial starts: There must be 21 or more days from the **end** of one IV antimicrobial course to the **beginning** of a second IV antimicrobial dose or course in an outpatient setting for two starts to be reported as separate dialysis events, even if different antimicrobials are used.

Positive blood cultures: There must be 21 or more days between positive blood cultures for each positive blood culture to be considered a separate dialysis event, even if organisms are different.

Pus, redness, or increased swelling: Count days between onset to onset.

There must be 21 or more days between the **onset** of a first episode and the **onset** of a second episode of pus, redness, or increased swelling at a vascular access site to be considered separate dialysis events.

**Examples:**

21 day rule for IV antimicrobial starts: A single dose of IV cefazolin is administered in the dialysis facility prophylactically prior to AV graft placement surgery. Within two weeks, patient shows signs of bloodstream infection and is started empirically on IV vancomycin. Report only one dialysis event for the IV cefazolin; the IV vancomycin was started within 21 days of the prophylactic dose and is therefore, not reported.

21 day rule for positive blood cultures: Patient has a positive blood culture on January 1, 22, and 24. Report two dialysis events: one for January 1 and one for January 22. The positive blood culture from January 24 is not reported because there are fewer than 21 days between January 22 and 24.

21 day rule for pus, redness, or increased swelling at the vascular access site: Patient’s tunneled central line exit site is slightly red on January 1. Over the course of four days, the redness worsens, and the vascular access site becomes warm to the touch, and tender. Patient receives a 10-day course of oral antibiotics, and the symptoms resolve. On January 19, the redness returns. Report one dialysis event: the second onset of redness on January 19 is within 21 days of the first onset of redness on January 1 and is therefore not reported.
